BIOGRAPHY

of the retired colonel/reserved colonel Sreten Egerić

Colonel Sreten Egerić was born on July 15, 1966 in Bačka Topola, SO Bačka Topola, Republic of Serbia.

He finished primary school in Lovćenac with excellent results, and two years of secondary school in Lovćenac, also with excellent results.

After it, he was accepted in 1983 at the SVŠ KoV Sarjevo, where he continued his education in the 30th A class, majoring in infantry. He graduated from the mentioned school in 1985 with excellent results.

After completing SVŠ KoV, he was assigned to the duty of commander of the 82mm mortar platoon in the Mixed Mortar Battery, First Infantry Battalion, 84.pp/41.pd, 3.A, in the garrison of Bitola.

During the one-year performance of his duties and the achieved excellent success in training and building the combat readiness of his unit, he was stimulated for the achieved results by being sent from the said unit for training in the 42nd A class at the VA KoV Belgrade in 1986.

After completing general education at VA KoV, he completed the second class of the intelligence-reconnaissance course at VA KoV in Pancevo. He completed his education at VA KoV in 1989, with excellent results.

After completing the VA KoV, he was assigned to the duty of the commander of the antiterrorist platoon in the 290th Battalion of the Military Police, Military and Naval Region, Split garrison.

In the mentioned garrison, he performed the duty of platoon commander, after successful tasks against separatist and paramilitary forces, he was appointed to the position of commander of the 1st VP company in the same battalion, until the start of combat operations in the territory of the former SFRY.

During the execution of the task of securing the VPO Command, on May 6, 1991, he was wounded while rescuing attacked soldiers from the ČOT/bVP, for which reason he was awarded a medal for bravery by the Presidency of the SFRY.

Starting on July 1, 1991, he was appointed as the commander of the VP company, within the 290th bVP, which position he held until the withdrawal of the JNA units from the area of R. of Croatia. During operations in the Split area, on December 18, 1991, he was wounded while overcoming and destroying the enemy's mine-explosive obstacles.

From March 20, 1992, he served as the commander of the VP company on special purpose armored personnel carriers, within the 290.bVP/86.zmp of the Military and Naval Region in the Kumbor garrison.

Starting on October 20, 1992, he was appointed commander of the VP/83.brOO company, Navy, in the Bar garrison. He performed this duty until September 1, 1994, when he was sent for further training in KŠŠ.

In the period from 01.02. by July 31, 1994, he completed the Military Police Course in the Pancevo garrison, with excellent success.

Starting from September 1, 1994 and until August 5, 1995, he was studying in the 44th class at the KŠŠ in the CVŠ Belgrade, when his schooling was interrupted due to combat operations in the territory of the former SFRY (operation "STORM"). In the period from 07.08. until 30.12.1995. in 1998, he performed the duties of commander of TG KoV–1 of the RM Corps. In the period from 01.01. until February 20, 1996, he continued his training at KŠŠ, which he completed with excellent success.

After completing the KŠŠ, he was assigned to the position of commander of the 2nd mtb/83rd mtbr, Corps of the Republic of Moldova, in the Bar garrison, where he served until March 1, 1997.

Starting on March 1, 1997, he was appointed to the position of Chief of the OONP in the 83rd Mtbr/KoRM command, where he held the position until June 1, 1998.

Starting from June 1, 1998, he was appointed to the position of deputy commander of the 10th Army/KoRM in the Zoganj (Ulcinj) garrison, where he held the position until December 27, 2000.

During the NATO aggression against the FRY in 1999, with the unit he successfully prevented the transfer of weapons, illegal crossings and the proliferation of narcotics across the state border with R. of Albania, for which he was awarded the Order of Merit in the Fields of Defense and Security, III degree by the President of the FRY.

Starting on December 27, 2000, he was appointed as the commander of the 10th Army/KoRM in the Zoganj (Ulcinj) garrison, where he performed the said duty until August 12, 2004, when he was transferred to the Belgrade garrison.

In the period from April 1 by June 1, 2000, he completed the Chief of Staff Course at CVVŠ Belgrade.

Starting on August 12, 2004, he was appointed to the position of Referee for B/G and the use of infantry units in the Infantry Directorate, KoV Sector, GŠ VSCG, in the Belgrade garrison, where he performed this duty until March 12, 2005, when he was transferred to the Novi Sad garrison.

Starting on March 12, 2005, he was appointed to the post of Chief of Staff in the command of the 18th Pbr/NSK in the Novi Sad garrison, after which on March 30, 2005, he was assigned to the post of commander of the 506th Pbr/NSK in the Zrenjanin garrison. During the execution of the task of rescuing the population and material goods due to floods in central and southern Banat, in the period from April 20 until June 1, 2005, the unit he commanded showed skill, sacrifice and success, which is why Colonel Egerić was awarded the Order of Merit in the Fields of Defense and Security, II degree by the President of SCG, and the unit was awarded the "Noble Feat" plaque for 2005.

Starting from October 1, 2005, he was appointed to the position of deputy commander of the 793rd LogB/NSK in the garrison of Novi Sad, he performed his duties until 01.07.2006. year, when he was appointed to the position of Chief of Staff in the newly formed 1st BrKoV VS, he performed this duty until he was sent for training at the Military Academy of Military Academy, in the Belgrade garrison, on October 1, 2010.

From July 4, 2011, he was appointed to the position of Head of the Department for Operational and Functional Capacities of the Ministry of Defense, within the Directorate for Operational Affairs of the Ministry of Defense. And from 01.11.2011. In 2008, he was appointed as the head of the Department for Operational and Functional Capabilities of the Ministry of Defense and Control of the Ministry of Defense.

In the period from January 20 until 04.07.2014. In 2008, he graduated from the Higher Security Studies of the Ministry of Defense of Serbia in Belgrade.

From March 15, 2015, he was assigned to the Training Command (KzO) as Assistant for Operations to the Commander of the KzO, in the Belgrade garrison. He retired from the above position on July 15, 2020.

During the service, for the achieved results in work and building the units' capabilities, self-effacing work and self-sacrifice, he was exceptionally promoted twice:

31.12.1991, in the rank of captain,

July 21, 2001, to the rank of lieutenant colonel.

During his service, he was repeatedly praised and rewarded for the results achieved by his superiors, including NGŠ VJ.

He was also awarded five more commemorative medals of the JNA, VJ and VS.

For the successful organization and management of a joint military exercise with the Armed Forces of the Republic of Hungary in 2008, by the Armed Forces of the Republic of Hungary. In Hungary, he was awarded the KoV OS Hungary plaque and the OS R Badge. Hungary.

He has been married to his wife Candy since July 28, 1991, and has two sons. He lives in Novi Sad.
